This certifies	, here referred to as Mare Owner/Agent, has purchased one					
service to the stallio	n TooFlyForAFrenchGuy, AQHA #X0728554 for the mare					
Reg #	for the 2023 breeding season beginning February 1 st , 2023 and ending July 1 st , 2023.					
This contract includes a stud fee of \$1500 which includes a \$500 booking fee and first cooled shipment.						
Breeding services and boarding as applicable are additional. Semen shipments are \$300 each. All						
payments must be made payable to Flying E Performance Horses & Repro, LLC.						

Pre-Breeding Arrangements: The mare owner must provide the following when making a booking:

- 1. Copy of registration certificate.
- 2. Completed & signed breeding contract. Please keep a copy for your records.
- 3. All Applicable Fees:
 - I. The booking fee, stud fee and shipping as applicable must be paid in full before any semen will be shipped.
 - II. <u>Any incomplete registration certification or unpaid charges (fees, shipping or shipping container)</u> will result in a hold of the mare's name on the appropriate stallion breeding report.

Breeding Arrangements:

- 1. Schedule will be subject to change due to the stallion's performance schedule. It is the mare owner's and his/her veterinarian's responsibility to confirm our breeding/shipping days in advance! To guarantee shipping, mare owner, or agent, must give a 3 day notice of possible semen shipment required. Must confirm shipment by 8am the day of collection. Call or text 254-338-5182
 - a. It is recommended to notify the stallion owner when it is planned for the mare to be checked for breeding purposes and to notify the stallion owner of the breeding plan and/or time frame at the time of checking the mare. This ensures the stallion owner has time to set up to have the stallion available for collection due to performance schedule.
- 2. Every effort will be made to accommodate your mare's breeding time-frame. However, it is the mare owner's responsibility to keep in touch so that your veterinarian can get your mare in foal in a timely manner. Failure to adhere to these arrangements may result in missed heats or delayed shipments, at the mare owner's expense. A veterinarian knowledgeable and successful in insemination techniques must oversee inseminations in order to maximize the potential of a timely pregnancy.
- 3. If a mare dies or is deemed unfit to breed during the breeding season, a substitute mare, approved by the stallion owner, may be bred without any additional breeding fee. There will be no refunds of any fees associated with this contract. Rebreeds in the event of a mare death must be used the following season. Shipping not included.

- 4. The mare owner agrees to have the mare checked by ultrasound no later than 20 days after insemination and notify the stallion owner of results in writing via message, text or email.
- 5. EMBRYO TRANSFERS: If more than one embryo survives from a single flush, the mare owner has the option to pay an additional (\$1000) stud fee for each additional surviving embryo once they successfully reach 30 days gestation. Should the owner decline this, all but the paid for viable embryos must be terminated. Any surviving embryo not paid for will not be listed on the breeding report.
- 6. In the event that TooFlyForAFrenchGuy becomes unable to breed, or dies, stud fee minus the booking fee will be refunded.
- 7. <u>Live foal guarantee:</u> A live foal is defined as one that will stand and nurse up to 24 hours old. If foal is born dead, mare owner agrees to furnish the stallion owner of the deceased foal within 24 hours by photographic proof only. The mare owner will have the right to substitute a different mare for the rebreeding providing that the substitute mare is of the same quality and condition as the original mare approved, determined at the stallion owner's discretion. In such a case return privileges will be available for one additional season only following original contract season. Rebreeds must pay any shipping charges applicable. If the mare owner fails to rebreed the mare the following year after original contract, does not provide proof in the above manner, or the foal dies after 24 hours post foaling, then any and all fees become forfeited, the right to rebreed is canceled and the stallion owner is released from all further obligation of this contract, unless otherwise agreed in writing and signed by both parties.
- 8. **NOTICE** Owners that choose to ride and/or compete on their mare during gestation may NOT be eligible for Live Foal Guarantee. This will be at the stallion owner's discretion.

Shipment Information:

- 1. Semen will be sent via Fed-EX/ UPS (next day arrival) at a rate of \$300 per shipment within the U.S. This MUST be paid PRIOR to COLLECTION of semen.
- 2. FedEx/UPS delivery is not available Sundays or some holidays. Mare owner should check with FedEx/UPS for weekend, holiday delivery or customer pickup. Local couriers MAY be available. Contact the stallion owner for more information.
- 3. PICK UP: Cooled semen that is picked up by a mare owner or agent will have a collection & packaging cost of \$100 charged.
- 4. All unreturned shipping containers will be charged to the mare owner's card on file. We will not process your contract without a credit card on file.

IMPORTANT. MUST READ: By filling out, signing and returning this contract to Flying E Performance Horses & Repro, LLC. I agree to the terms listed. I agree that I am solely responsible for carrying out my part as mare handler/owner. I agree that I am responsible for all of the financial duties listed in this contract. I have read and understand this contract in its entirety.

Payment Information:

All payments may be made by cash, check, or with Visa, Master Card, or American Express credit cards. If paying by credit card, a 3% transaction fee will apply. All shipping and charge fees are subject to change (with
